



Students may follow a variety of pathways for their senior studies.

While studying at school, students can also be enrolled in one course at TAFE- called EVET courses.



ATAR pattern of study

The ATAR (Australian Tertiary Admissions Ranking) pattern of study is in preparation for university.

To apply for university admission for the year after you complete Year 12, you will need to study an ATAR pattern.

To be eligible for an ATAR in NSW from 2025, you must satisfactorily complete at least:

- 10 units of Board Developed courses which includes:
 - o 2 units of English
 - o three Board Developed courses of 2 units or greater
 - o four subject areas.

NON-ATAR pattern of study

The NON-ATAR (Australian Tertiary Admissions Ranking) pattern of study leads to a Vocational Pathway after school— such as Apprenticeships, Traineeships, Retail and Hospitality careers



Requirements for gaining a higher school certificate

Students must have a minimum of 3 Board Developed courses in their pattern of study in both year 11 and year 12.



Units of study

To meet HSC requirements, you must complete the following patterns of study:

- preliminary pattern must include at least 12 units
- HSC pattern must include at least 10 units.

Both patterns of study must include at least:

- 6 units of Board Developed Courses
- 2 units of a Board Developed Course in English
- 3 courses with 2 or more units, either Board Developed or Board Endorsed Courses
- 4 subjects.



Timetable and subject conflicts

After the timetabling process has been completed and the lines are determined, students who have any conflicts of chosen subjects will be re-interviewed by the Careers Adviser



Assumed level of knowledge

There is an assumed level of knowledge expected when studying some courses.

For example, students who choose Engineering Studies, it is recommended they also choose to study Physics and Mathematics Advanced. Please see the Head Teacher if you are unsure of the requirements.



Exclusions

Students are **unable** to study:

- more than three Science courses
- both Furniture Making and Industrial Technology Timber courses
- both Hospitality courses
- more than one Industrial Technology subjects
 - they must choose either Automotive, Timber OR Metal
- more than one Sport Lifestyle and Recreation subjects
- Retail Services at school if they are enrolled in EVET courses for Salon Assistant (Hairdressing) or Beauty.



Course availability

All Courses offered will be subject to availability, which will depend on the number of students choosing each course and the staffing in 2025.

SUBJECT	HSC UNITS	ATAR Eligibility
English Extension 1	1	YES

English Extension I is designed for students undertaking English Advanced who choose to study at a more intensive level in diverse but specific areas. They enjoy engaging with complex levels of conceptualisation and seek the opportunity to work in increasingly independent ways.

Additional Information:

Students wishing to take Extension 2 English in Year 12, MUST select the English Extension 1 Course in Year 11 and Year 12.

SUBJECT	HSC UNITS	ATAR Eligibility
English Advanced	2	YES

English Advanced is designed for students to undertake the challenge of higher-order thinking to enhance their personal, social, educational and vocational lives. These students apply critical and creative skills in their composition of and response to texts in order to develop their academic achievement through understanding the nature and function of complex texts.

Students who have a strong interest and ability in English should also consider the Extension course.

Students who study the Advanced course will be well equipped for further study of English and related disciplines at tertiary level.

SUBJECT	HSC UNITS	ATAR Eligibility
English Standard	2	YES

English Standard is designed for all students to increase their expertise in English and consolidate their English literacy skills in order to enhance their personal, social, educational and vocational lives. The students learn to respond to and compose a wide variety of texts in a range of situations in order to be effective, creative and confident communicators.

Students who study the Standard course will be equipped for employment, TAFE and tertiary study. This course may not be suitable for students who wish to study English or related subjects at university (check university course prerequisites carefully before choosing your preliminary courses).

SUBJECT	HSC UNITS	ATAR Eligibility
English Studies	2	▲ YES

English Studies is designed for students who wish to refine their skills and knowledge in English and consolidate their English literacy skills to enhance their personal, social, educational and vocational lives.

It is a course for students who wish to be awarded a Higher School Certificate but who are seeking an alternative to the English Standard course.

Students have an opt-out option for their Year 12 Examination in this course, however if they do not do the examination, this course cannot be counted in their ATAR calculation.



English Life Skills	2	NO

English Life Skills Course is designed for students with special education needs who are unable to access the outcomes of the Stage 6 English courses even with adjustments to teaching, learning and assessment.

It provides an opportunity for students to engage in personalised learning of English through the selection of outcomes and content relevant to the student's abilities, needs and interests. Students undertaking English Life Skills are eligible for the award of the Higher School Certificate.

Mr Jonovski - Head Teacher Mathematics

SUBJECT	HSC UNITS	ATAR Eligibility
Mathematics Extension 1	1	YES

The Mathematics Extension 1 course builds on the concepts introduced through the mathematics course and can only be selected if Mathematics Advanced is studied.

The content and depth of treatment of algebra and calculus in this course is intended for students who have successfully completed Stage 5.3 Mathematics and who have demonstrated a mastery of all mathematical skills at this level. It is intended to further develop the skills needed to study mathematics and physical and engineering sciences at tertiary level.

NOTE:

It is suggested that students achieving a Grade A10 or A9 would be suited to this course.

Additional Information:

Students wishing to take Extension 2 Mathematics in Year 12, MUST select the Extension 1 Mathematics course in Year 11 and Year 12

SUBJECT	HSC UNITS	ATAR Eligibility
Mathematics Advanced	2	YES

This course is intended for students who have successfully completed Stage 5.3 Mathematics and who have shown competence in the skills needed for that course. The Mathematics Advanced Course will further develop the algebraic and calculus aspects of the 5.3 course with relevance and application to the real world. The subject is rigorous and links well to tertiary studies in areas such as the physical sciences, computer sciences and engineering.

Additional Information:

It is suggested that students achieving Grade A10, A9, B8 would be suited to this course. Where a student has not reached the level indicated further topics may need to be covered before attempting this course.

SUBJECT	HSC UNITS	ATAR Eligibility
Mathematics Standard	2	YES

Students of Mathematics Standard 2 course study a common Year 11 course, which leads to Mathematics Standard 1 or Mathematics Standard 2 in year 12. This course is designed to promote the development of knowledge, skills and understanding in areas of mathematics that have direct application to a broad range of human activity. The Mathematics Standard 2 pathway provides a strong foundation for students entering the workforce and/or undertaking further training and for university courses in the humanities, nursing and paramedical sciences.

Additional Information:

Students who have chosen to study the Mathematics Standard 2 in Year 11 can move to the Standard 1 course in year 12.

SUBJECT	HSC UNITS	ATAR Eligibility
Mathematics Studies	2	NO

Students of the Mathematics Studies course follow the Year 11 Standard program with applied accommodations to focus more on real-world application, leading into the Year 12 Mathematics Standard 1 pathway. This course is designed to prioritise development of knowledge, skills and understanding in key areas of mathematics that directly apply to workforce skills and everyday use.

Mr Mesina - Head Teacher Science

SUBJECT	HSC UNITS	ATAR Eligibility
Investigating Science	2	YES

The ongoing study of science, the specific Working Scientifically skills processes, and their application have led humans to accumulate an evidence-based body of knowledge about human interactions – past, present and future – with the world and its galactic neighbourhood. The course is firmly focused on developing the Working Scientifically skills, as they provide a foundation for students to value investigation, solve problems, develop and communicate evidence-based arguments, and make informed decisions.

The Investigating Science course is designed to complement the study of the science disciplines by providing additional opportunities for students to investigate and develop an understanding of scientific concepts, their current and future uses, and their impacts on science and society.

The knowledge, understanding and skills gained from this course are intended to support students' ongoing engagement with science, and to form the foundation for further studies and participation in current and emerging STEM-related post-school activities and industries.

SUBJECT	HSC UNITS	ATAR Eligibility
Earth and Environmental Science	2	YES

Earth and Environmental Science explores the Earth's renewable and non-renewable resources and environmental issues. An understanding of the Earth's resources and the ability to live sustainably on the planet is a central purpose of the study of Earth and Environmental Science. Students engage with inquiry questions to explore knowledge of the Earth. They also undertake practical and secondary-sourced investigations to acquire a deeper understanding of the Earth's features and naturally occurring phenomena and cycles.

Fieldwork is an integral part of these investigation processes. Earth and Environmental Science involves the analysis, processing, and evaluation of qualitative and quantitative data in order to formulate explanations and solve problems. In conjunction with knowledge and understanding, communication skills are essential in forming evidence-based conclusions or arguments.

The course provides the foundation knowledge and skills required to study earth and environmental science after completing school and supports participation in careers in a range of related industries. The application of earth and environmental science is essential in addressing current and future environmental issues and challenges. It is also necessary for the use and management of geological resources that are important to Australia's sustainable future.

SUBJECT	HSC UNITS	ATAR Eligibility
Biology	2	YES

Biology studies the diversity of life from a molecular to a biological systems level and examines the interactions between living things and the environments in which they live. In this course students explore the application of Biology and its significance in finding solutions to health and sustainability issues in a changing world and the future development of biotechnologies. By applying Working Scientifically processes, students will complete a compulsory depth study in biology topics of their interest. Therefore, they are provided with opportunities to design and conduct biological investigations both individually and collaboratively.

The course provides the foundation knowledge and skills required to study biology after completing school and supports participation in a range of careers in biology and related interdisciplinary industries. It is a fundamental discipline that focuses on personal and public health and sustainability issues and promotes an appreciation for the diversity of life on the Earth and its habitats.

SUBJECT	HSC UNITS	ATAR Eligibility
Chemistry	2	YES

Chemistry study and explores the structure, composition and reactions of and between all elements, compounds and mixtures that exist in the Universe. The discovery and synthesis of new compounds, the monitoring of elements and compounds in the environment, and an understanding of industrial processes and their applications to life processes are central to human progress and our ability to develop future industries and sustainability. The course further develops an understanding of chemistry through the application of Working Scientifically skills. It focuses on the exploration of models, understanding of theories and laws, and examination of the interconnectedness between seemingly dissimilar phenomena. Chemistry involves using differing scales, specialised representations, explanations, predictions and creativity, especially in the development and pursuit of new materials. It requires students to use their imagination to visualise the dynamic, minuscule world of atoms in order to gain a better understanding of how chemicals interact.

The course provides the foundation knowledge and skills required to study chemistry after completing school, and supports participation in a range of careers in chemistry and related interdisciplinary industries. It is an essential discipline, that currently addresses and will continue to address our energy needs and uses, the development of new materials, and sustainability issues as they arise.

SUBJECT	HSC UNITS	ATAR Eligibility
Physics	2	YES

Physics involves the study of matter and its motion through space and time, along with related concepts that include energy and force. Physics deals with the study of phenomena on scales of space and time – from nuclear particles and their interactions up to the size and age of the Universe. This allows students to better understand the physical world and how it works, appreciate the uniqueness of the Universe, and participate in navigating and influencing the future. The problem-solving nature of physics further develops students' Working Scientifically skills by focusing on the exploration of models and the analysis of theories and laws, which promotes an understanding of the connectedness of seemingly dissimilar phenomena.

Students who study physics are encouraged to use observations to develop quantitative models of real-world problems and derive relationships between variables. They are required to engage in solving equations based on these models, make predictions, and analyse the interconnectedness of physical entities.

The study of physics provides the foundation knowledge and skills required to support participation in a range of careers. It is a discipline that utilises innovative and creative thinking to address new challenges, such as sustainability, energy efficiency and the creation of new materials.

SUBJECT	HSC UNITS	ATAR Eligibility
Marine Studies	2	NO

This course involves study to develop an awareness of the scope and diversity of marine ecosystems, a sense of responsibility, respect, and the need for wise management practices when dealing with marine resources. It also looks at the impact of human demands on these fragile ecosystems.

Marine Studies may assist students who wish to work in marine or conservation related occupations.

Additional Information:

Completion of a Senior First Aid Certificate is a mandatory requirement.

Mrs Harvey-Trappel – Head Teacher Creative and Performing Arts

SUBJECT	HSC UNITS	ATAR Eligibility
Drama	2	YES

In the Drama course, students will learn performance skills and about the Elements of Drama. Students study the practices of Making, Performing and Critically Studying Drama. Students engage with these components through collaborative and individual experience.

Preliminary Course

The Preliminary Drama course comprises of Improvisation, Play Building and Acting, the Elements of Production in Theatrical Traditions and Performance Styles, as well as critical analysis of Drama.

HSC Course

In the HSC, Drama students will complete a Group Performance, a Written Exam and an Individual Project. The Individual Project requires students to demonstrate expertise in a particular area, which can be in the form of a Monologue Performance, Critical Analysis, Costume Design, Program Design, Scriptwriting or Video Drama.

SUBJECT	HSC UNITS	ATAR Eligibility
Music 1	2	YES

The Music 1 Course caters for students who range from those with beginner instrumental and/or vocal skills to those with highly developed performance skills in a variety of styles. The course aims to develop the practical and performance skills of the student, as well as aural and listening skills.

HSC Course

In the HSC course, students will complete and Aural Exam, a Core Performance as well as 3 electives, which can be Performance, Composition or Viva Voce.

Music 1 assumes no prior knowledge of musical notation beyond the basic introduction in Years 7-10. It recognises that students who have no further involvement in Music beyond the Mandatory Course, will need to revisit elementary musical skills and understanding.

SUBJECT	HSC UNITS	ATAR Eligibility
Photography, Video & Digital Imaging	2	NO

This course in Photography will allow students to:

- Increase visual awareness of their environment and the way photography representations can be created from this to communicate ideas and feelings.
- Develop and understanding of the methods photographers use to build meanings.
- Develop skills through the acquisition of the techniques of photography.
- Use photography as a means of visual communications and a process to aid observations and analysis.
- Gain an understanding of careers involving photography.

SUBJECT	HSC UNITS	ATAR Eligibility
Visual Arts	2	YES

Visual Arts involve students in art making, art criticism and art history. Students develop their own artworks, culminating in a "Body of Work" in their preferred media for the HSC course. Students critically and historically investigate artworks, critics, historians and artists from Australia and other cultures.

Preliminary Course

In the Visual Arts Preliminary Course, students learn and explore a variety of artmaking skills and techniques in several different media. They investigate a broad range of contemporary and historic artists and art movements for critical and historical analysis. There is an emphasis on the development of creativity and originality that is recorded in the Visual Arts Diary.

HSC Course

In the HSC, Students complete several case studies on artists and artworks from a range of different and historical contexts. Students will also complete a written exam and develop and create their own Body of Work in a medium of their choosing.











Mr Te Rangi (Rel.) – Head Teacher Human Society and Its Environment

SUBJECT	HSC UNITS	ATAR Eligibility
Aboriginal Studies	2	YES

Aboriginal Studies develops students' knowledge and understanding about the historical and contemporary experiences of Aboriginal peoples and the concept of 'shared histories' with a view to enabling students to be active and informed citizens in promoting a just society for all Australians. The course covers a broad range of contemporary social and political issues such as health and educational outcomes for Aboriginal people. It involves comparative studies of different Aboriginal and international Indigenous communities.

Excursions to Aboriginal sites and communities are integrated into the course and all students will be involved in community consultation.

The HSC course includes a Major Project of the student's choice.

SUBJECT	HSC UNITS	ATAR Eligibility
Ancient History	2	YES

YEAR 11 STUDIES

In Year 11 students develop an understanding for the nature of Ancient History through an investigation of relevant archaeological methods and skills used in the evaluation and analysis of important sites. Students will then use this knowledge to complete the following case studies examining a variety of different Ancient Societies:

- Investigating Ancient History The Nature of Ancient History
- The Trojan War
- A Historical Investigation of the student's choice
- Persepolis
- Rome Power and Image
- Egypt Death and Funerary Customs

YEAR 12 STUDIES

In Year 12 students will continue to develop these skills of historical investigation, and understanding by undertaking the following case studies:

- Cities of Vesuvius Pompeii and Herculaneum,
- Spartan Society to the battle of Leuctra 371BC,
- New Kingdom Egypt Amenhotep III to the death of Ramesses II
- Akhenaten

SUBJECT	HSC UNITS	ATAR Eligibility
Modern History	2	YES

YEAR 11 STUDIES

In Year 11, students develop an understanding of the nature of Modern History through an investigation of relevant methods and skills used in source analysis and research of important events in history. Students will then use this knowledge to complete the following case studies:

- Decline and fall of the Romanov Dynasty
- The Nature of Modern History The representation and commemoration of the past
- A Historical Investigation of the student's choice
- The Cuban Revolution
- Shaping the Modern World World War One
- Students complement this with the study of 2 case studies

YEAR 12 STUDIES

In Year 12 Students will continue to develop these skills of historical investigation and understanding by undertaking the following case studies:

- Power and Authority in the Modern World 1919 1946
- Russia and the Soviet Union 1917 1941
- Civil rights in the USA 1945 1968
- Conflict in the Pacific 1937 1951

SUBJECT	HSC UNITS	ATAR Eligibility
Business Studies	2	YES

Business studies is an exciting course that focuses on the role of business—especially business in Australia and the world. Students are guided through a variety of activities and experiences to develop their understanding of business operation including marketing, employment relations, global business, finances, human resources, and the management of modern businesses. Students complete an in-depth research assignment and a variety of case studies on contemporary businesses.

Additional Information:

Business Studies combines well with Legal Studies, CAFS and Accounting at TAFE. Students interested in a career in marketing, human resource management or business management should do this course.

SUBJECT	HSC UNITS	ATAR Eligibility
Geography	2	YES

Geography in Years 11 and 12 involves developing knowledge and understanding about the characteristics and distribution of different environments. Students study the process that form and transform the features of these environments. They also learn about local and global forces which impact on people, ecosystems, urban places and economic activity. Students will develop skills to investigate and communicate geographically.

Additional Information:

Students must participate in a number of field study excursions in both Year 11 and 12 as a requirement of the course.

SUBJECT	HSC UNITS	ATAR Eligibility
Legal Studies	2	YES

This course develops student's awareness and understanding of our legal system and how it operates. It focuses on law and society, crime, the Constitution and the role of the individual, Family and International Law. Legal Studies examines how laws are made and the basis for them through a variety of case studies and investigations of real legal cases.

Students' abilities to investigate, analyse and synthesise are developed through opportunities to be involved in Mock Trials, visits to the Local Court and Parliament House. The course develops skills that complement a broad range of other subjects and will prepare students for careers in law, business and environmental management.

SUBJECT	HSC UNITS	ATAR Eligibility
Society and Culture	2	YES

This course aims to develop a student's knowledge, understanding, skills, values and attitudes essential to achieving social and cultural literacy. It investigates the interactions between persons, society, cultures and environment across time. Society and Cultures is a subject suited to students who are keen to learn about how their own culture and other cultures work through an investigation of concepts such as adolescence, coming of age and rites of passage, belief systems and popular culture.

Additional Information:

Completion of a compulsory Personal Interest Project (PIP) is part of the HSC.

SUBJECT	HSC UNITS	ATAR Eligibility
Economics	2	YES

Economics provides understanding for students about many aspects of the economy and its operation that are frequently reported in the media. It investigates issues such as why unemployment or inflation rates change and how these changes will impact on individuals in society. Economics develops students' knowledge and understanding of the operation of the global and Australian economy. It develops the analytical, problem-solving and communication skills of students. There is a strong emphasis on the problems and issues in a contemporary Australian economic context within the course.

The Preliminary Course:

In the Preliminary and HSC courses, students will develop the linguistic and intercultural knowledge and understanding, and the speaking, listening, reading and writing skills to communicate in Japanese. Topics studied through two interdependent perspectives, the personal world and the Japanese-speaking communities, provide contexts in which students develop their communication skills in Japanese and their knowledge and understanding of language and culture.

Students' skills in, and knowledge of, Japanese will be developed through tasks associated with a range of texts and text types, which reflect the topics. Students will also gain an insight into the culture and language of Japanese-speaking communities through the study of a range of texts.

Main Topics Covered:

- Family life, home and neighbourhood
- People, places and communities
- Education and work
- Friends, recreation and pastimes
- Holidays, travel and tourism
- Future plans and aspirations.

Eligibility:

Strict eligibility rules apply to the study of this subject.

- 1. It is intended to cater only for students with no prior knowledge or experience of the Japanese language, either spoken or written, or whose experience is derived solely from or is equivalent to, its study for 100 hours or less in stage 4 or 5.
- 2. Students who study this course cannot be native speakers, or have been an exchange student in Japan or a Japanese speaking country.

Additional Information:

The course is recommended for students interested in learning a second language to give them an advantage in careers such as catering, international finance, law, journalism, tourism and hotel management.

Community & Family Studies	2	YES

CAFS is designed for the students to develop an understanding of the diverse nature and interdependence of families and communities in relation to the changing nature of Australian Society. The course focuses on enabling students to plan and manage resources efficiently, while focusing on people and relationships.

The Preliminary Year topics cover: Resource Management, Individuals and Groups, Families and Communities.

The HSC course builds on these through a study of Groups in Context, Research Methodology (for the major project), Parenting and Caring, as well as an optional topic.

Exams and Assessment:

- Preliminary Course = 2 assessments and yearly examination
- HSC Course = 3 assessments and Trial HSC examination

Additional Information:

The study of CAFS provides students with knowledge, understanding and skills that form a valuable foundation for a range of courses at university and other tertiary institutions. In addition, the study of CAFS assists students to prepare for employment and full and active participation as citizens. There are opportunities for students to gain recognition in Vocational Education and Training.

These pathways could include: Business Management, Human Resource Management, Teaching, Social Work, Child Care worker, Nursing, Counselling, Marketing etc.

Sports, Lifestyle & Recreation	2	NO

SLR enables Stage 6 students to build upon their learning in Years K–10 Personal Development, Health and Physical Education. Specifically, it focuses on those aspects of the learning area that relate most closely to participation in sport and physical activity.

SLR makes a positive contribution to the total wellbeing of students. They develop knowledge and understanding of the value of activity, increased levels of movement skill, competence in a wide variety of sport and recreation contexts and skills in planning to be active. These and other aspects of the course enable students to adopt and maintain an active lifestyle.

Exams and Assessment:

- Preliminary Course: 3 assessments (mix of practical and theoretical)
- HSC Course: 4 assessments (mix of practical and theoretical)

Additional Information:

SLR is both a practical and theoretical based subject. It is a non-ATAR subject that is well suited to students studying 5 ATAR based subjects who are looking for an opportunity to engage in a more practical based option.

This course caters for a wide range of student needs. It can assist students in developing:

- the qualities of a discerning consumer and an intelligent critic of physical activity and sport
- high levels of performance skill in particular sports
- the capacity to adopt administrative roles in community sport and recreation
- the skills of coach, trainer, first aid officer, referee, and fitness leader. In the context of this course, it may be possible for students to acquire recognised qualifications in these areas.

SUBJECT	HSC UNITS	ATAR Eligibility
Health & Movement Science	2	YES

The course examines a range of areas that underpin health and movement science. Study focuses on the management of personal and community health, as well as factors that affect and improve physical performance.

Health and Movement Science draws on a multitude of fields and the application of scientific concepts to actively engage students in learning about the factors that influence health and movement. While there is tremendous opportunity for good health, there are numerous conflicting influences on lifestyle, which are impacting health outcomes. In this syllabus, students investigate the health status of Australians and the interrelated factors that affect the health of individuals and communities. Students explore the factors that influence movement and performance, and develop the skills to enhance movement for themselves and others throughout their lifetime.

Students develop skills of critical inquiry and practical application in investigating the course content.

- Preliminary Course: Health for individuals and communities; and The body and mind in motion.
- HSC Course: Health in an Australian and global context; and Training for improved performance.

Exams and Assessment:

- Preliminary Course: 2 assessments, as well as a Yearly examination.
- HSC Course: 3 assessments, as well as the Trial HSC examination.

Additional Information:

Note: This course has a significant theory base with limited practical opportunities.

Completion of this course may give students an advantage in career pathways involving medicine, physiotherapy, nursing, teaching and the sport and recreation industry.

Design and Technology	2	YES

The Preliminary Course is a design-based course. Students will study the theory of design and move through a series of design briefs that they will solve with practical projects.

The HSC course involves the students in design and making a Major Design Project and Portfolio of their choice. This is where the strong elements of design come together. A variety of mediums may be used such as timber, steel, stainless steel, alloys, ceramics and textiles. Students are also able to work with alternative media such as graphics design, multimedia, software development and computing. Scope is given to the designing of products; but thinking from another direction. Designers are studied and students gain an insight into a variety of design trends.

Exams and Assessment:

- Preliminary Course: 2 assessments + yearly
- HSC Course: 2 assessments, Trial Exam + externally assessed major project and design portfolio

Additional Information:

This course focuses on design and development of a product rather than the production process.

Engineering Studies	2	YES

Both Preliminary and HSC courses offer students the knowledge, understanding and skills in a variety of aspects of engineering. Students will learn about what engineers do in their daily lives. They will learn to test things and report like real engineers.

Students will be constructing models of engineering concepts. While it may be seen as an excellent start for future engineers, it is also interesting for students who wish to develop their technical knowledge. Topics such as civil, aeronautical, biomedical, electrical, mechanical are all investigated.

Exams and Assessment:

- Preliminary Course: 2 assessments + yearly
 HSC Course: 3 assessments + Trial Exam
- **Additional Information:**

Students who do this course could also be studying Mathematics Advanced and Physics (or Chemistry).

Exploring Early Childhood	2	NO

Students will develop an awareness and understanding growth, development and learning in young children and will recognise their uniqueness and those with special needs. Students will also become aware of learning through play and safe environments, and identify the range of services provided for young children and their families.

The course includes practical applications. Course topics include child growth and development, play, positive interaction with young children, along with 6 options such as pregnancy and childbirth, or food and nutrition. The "Parenting Simulation" is a feature of the Year 11 course.

Students will develop knowledge and understanding about the production, processing and consumption of food, the nature of food, human nutrition and an appreciation of the importance of food to health and its impact on society. Exams and Assessment:

- Preliminary Course: 2 assessments + yearly
- HSC Course: 3 assessments + Trial Exam

Industrial Technology – Automotive	2	YES

This course consists of Project Work and an Industry Study that develops a broad range of skills and knowledge as well as an introduction to industrial processes and practices.

In the Preliminary course, students must design, develop and construct a number of projects. Each project must include a management folio. Students also undertake the study of an individual business within the industry.

In the HSC course, students must design, develop and construct a major project with a management folio. They also undertake a study of the overall industry related to the automotive industry.

- HSC Course: 2 assessments, Trial Exam + externally assessed major design project and management folio

The HSC Course builds on the Preliminary course and involves the study of another culture, historical developments in textiles, contemporary designers, dyeing and printing innovations, emerging textiles and current issues in the Australian Textile Industry.

The HSC involves producing a Major Textiles Project, with a folio and practical item.

School Delivered VET (SVET)

NSW Public Schools Registered Training Organisations deliver a range of courses leading to industry qualifications. These courses are delivered in school, by qualified teachers giving you access to industry standard training within your day-to-day school timetable.

Students will have access to industry standard training facilities at school and/or in the workplace and through work placement can develop workplace behaviours and attitudes sought after by employers. Stage 6 VET courses are designed for students in Years 11 and 12. These courses develop the skills and knowledge leading you toward a successful transition from school to employment or further education and training. In some cases, these courses may lead to direct entry in a related university course.

Trade Training (TTC)

Students who want to fast track getting the Certificate Qualification or a Statement of Attainment, in one of the trade training courses listed below, can do so by studying the 4 units of this course in Year 11.

These Courses are recognised both in Industry and at TAFE.

This pattern of study is to attend the course every Monday and Wednesday afternoon for 4 terms, at the Host School. As this is an accelerated course, students must complete 70 hours of compulsory Work Placement in ONE year.

The advantages of this pattern of study are:

- 2 of the units are for Year 11 and 2 of the units are for Year 12, so this reduces the workload in Year 12.
- If this course is being included in the ATAR calculations, the exam can be done at the end of Year 11, which reduces the number of exams done in Year 12.

Course cost:

The Trade Training Course fee (TBA) includes the required uniform and footwear, course notes, and all compulsory additional expenses for studying the course.

Payment of the fee:

Students must register for these courses and pay a deposit of \$150, before the end of Term 3, to secure a place in the Trade Training Course of their choice.

These TAFE courses are classified as Industry Curriculum Framework (ICF) and can contribute to your ATAR. However, you must do the HSC Examination for the subject if you wish to include it in the ATAR calculation.

- Each course includes compulsory Work Placement hours for Year 11 and Year 12.
- These courses allow students in Years 11 and 12 to study selected TAFE vocational subjects while still at school, which can give them a head-start in a career.
- Each of the courses listed on the next page may be studied in conjunction with being employed as a School Based Apprenticeship/Traineeship in that industry.

How to enrol:

Expressions of interest for an EVET course must be made through Gorokan High School.

- At the **Subject Selection Interview** with the Careers Adviser, students must discuss their interest in applying for an EVET Course.
- Following this interview a check will be done to determine if the student meets the school and TAFE criteria.
- The Careers Adviser will be notified by the program of which courses are being funded and which students are accepted into those courses.
- Enrolment forms will then be issued for completion and to be signed by the student and a parent before it is returned to the Careers Adviser.

Additional information:

- Attendance is compulsory.
- Students are responsible for paying their own travel expenses to and from TAFE every week. School bus passes cannot be used for free travel.
- For students seeking admission to university if you are NOT including a SVET course as one of your other subjects ONE of these courses may be used in the calculation of an ATAR.

This course aims to provide students with a broad overview of the engineering field and prepares for entry into employment as an apprentice or trainee in the areas of mechanical, fabrication, electrical, automotive and electronics engineering. This course prepares you for employment in the metals, engineering and manufacturing industries. Students undertaking this program will learn a range of fabrication and machining skills and work with welding, lathes and milling machines as well as learning about hand and power tools and precision measurement tools.

Where can this course take me?

Potential job roles include: operator-production worker or operator-process worker; factory worker; metal production assistant; sheet metal worker; machinist; equipment maintainer & repairer; plant mechanic; mechanical fitter; tool and die maker; design engineer; CNC operator; mechanical and maintenance engineer. The course also provides a pathway into fabrication and engineering trades in qualifications such as MEM30219 Certificate III in Engineering - Mechanical Trade and MEM30319 Certificate III in Engineering - Fabrication Trade.

Stage 6 School Delivered Vocational Education and Training (VET) Courses

Stage 6 Vocational Education and Training (VET) courses are offered as part of the Higher School Certificate (HSC)). VET courses are designed to deliver workplace specific skills and knowledge and cover a wide range of careers and industries. VET courses for secondary students are developed by NSW Educational Standards Authority (NESA) and are based on national training packages.

Stage 6 VET courses allow students to gain an HSC or and a national qualification or statement of attainment as part of the Australian Qualification Framework (AQF). These qualifications are widely recognised by industry, employers, tertiary training providers and universities and will assist students to progress to various education and training sectors and employment.

NSW Public Schools RTO is accredited to deliver and assess VET qualifications to secondary students. It is mandatory for all students studying a VET course to create a Unique Student Identifier (USI) upon enrolment. Students will require a form of identification for the creation of the USI. Examples include a Medicare Card, Australian Birth Certificate, Driver's License or a valid Passport.

Assessment in all VET courses is competency based. The student is assessed on what they can do (skills) and what they know (knowledge) to equip them in the workplace. Students are either deemed "competent" or "not competent" by the teacher. Students who have successfully achieved competency will have the skills and knowledge to complete workplace activities in a range of different situations and environments, to an industry standard expected in the workplace.

Assessment materials are designed to ensure each learner has the opportunity to achieve outcomes to the level of the qualification. Students will receive documentation showing all achieved units of competency.

Board Developed Industry Curriculum Framework (ICF) courses usually count for 4 units of HSC credit, include 70 hours of mandatory work placement, and have an optional HSC examination. For a VET course to be included in the calculation for the ATAR, students must sit the HSC Examination.

Board Endorsed Courses (BECs) are courses based on national industry Training Packages endorsed by NESA. They do not count towards the ATAR and there is no HSC examination.

Work Placement


